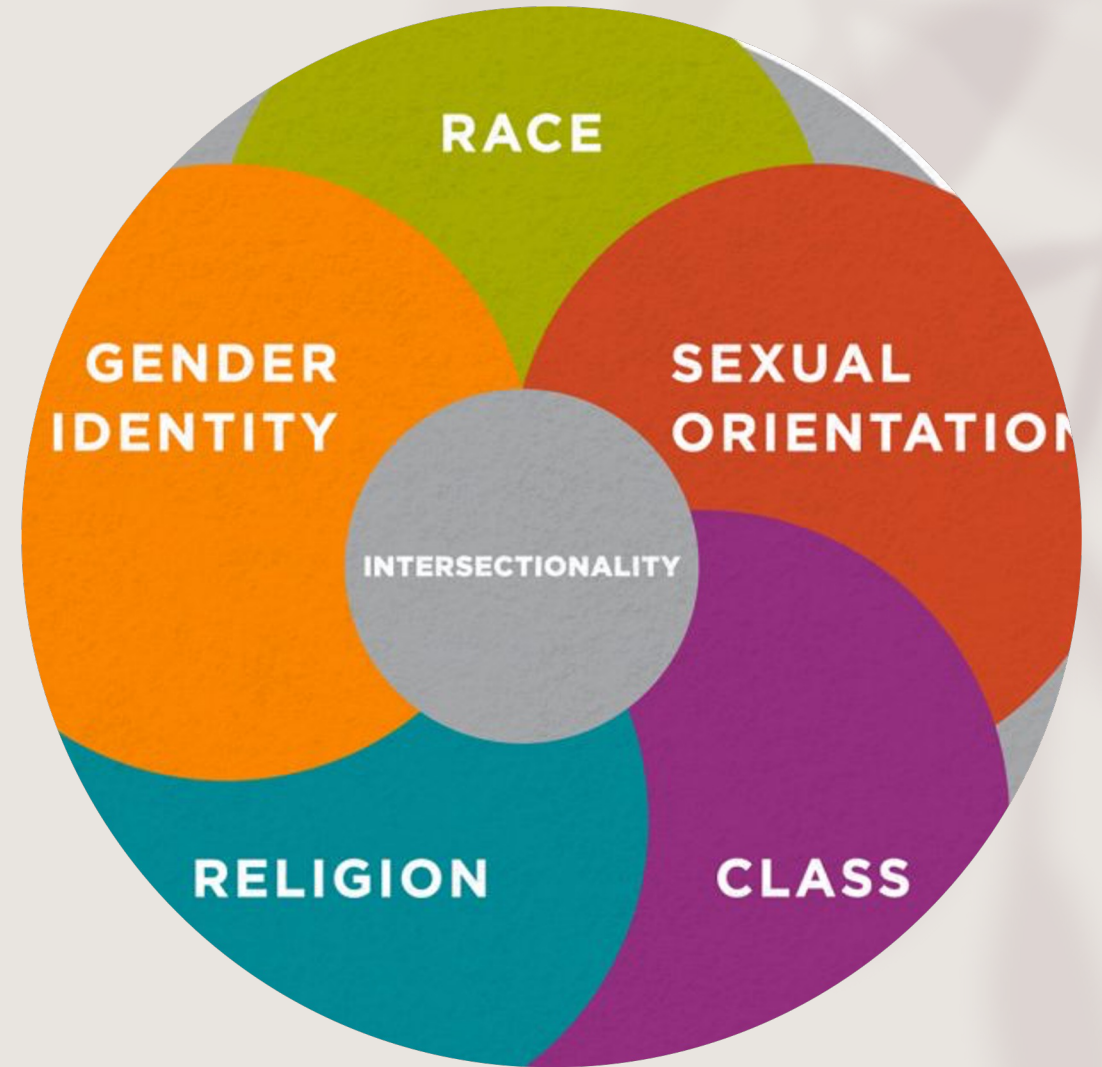

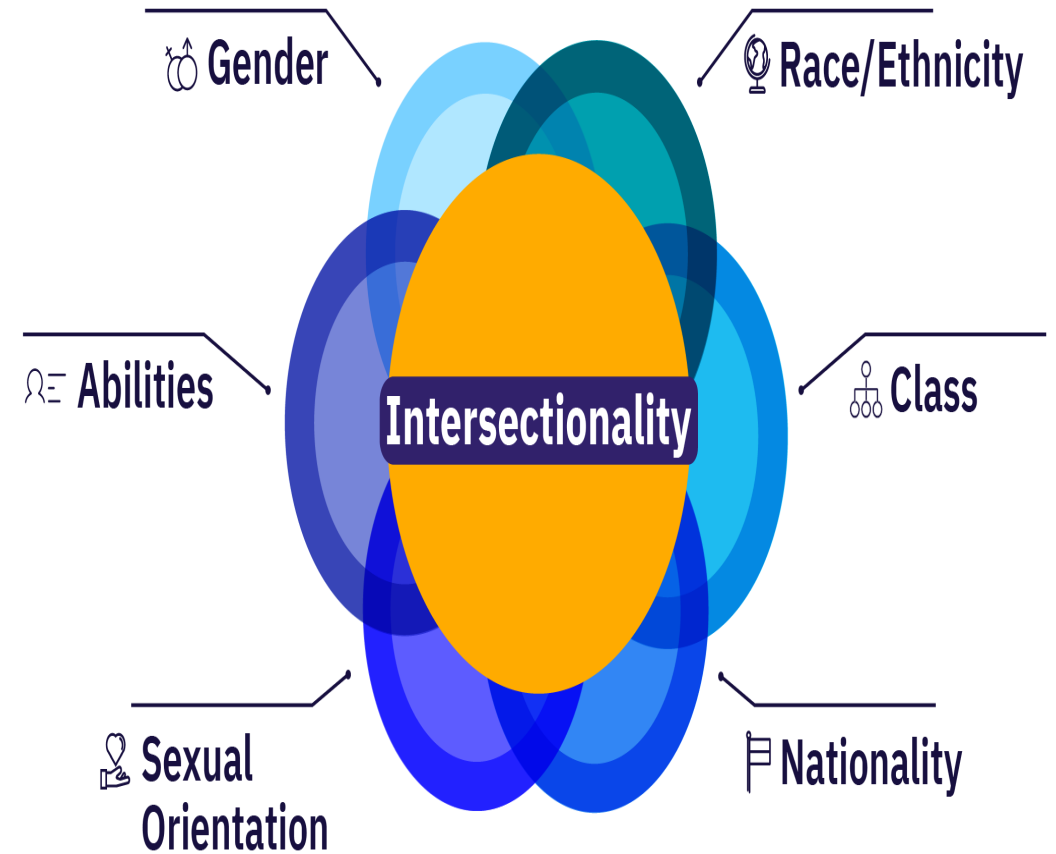


Definition of Intersectionality

Intersectionality has been used in different contexts, including academia, social activism, and policy-making, and has been both celebrated and criticized for its potential and limitations.

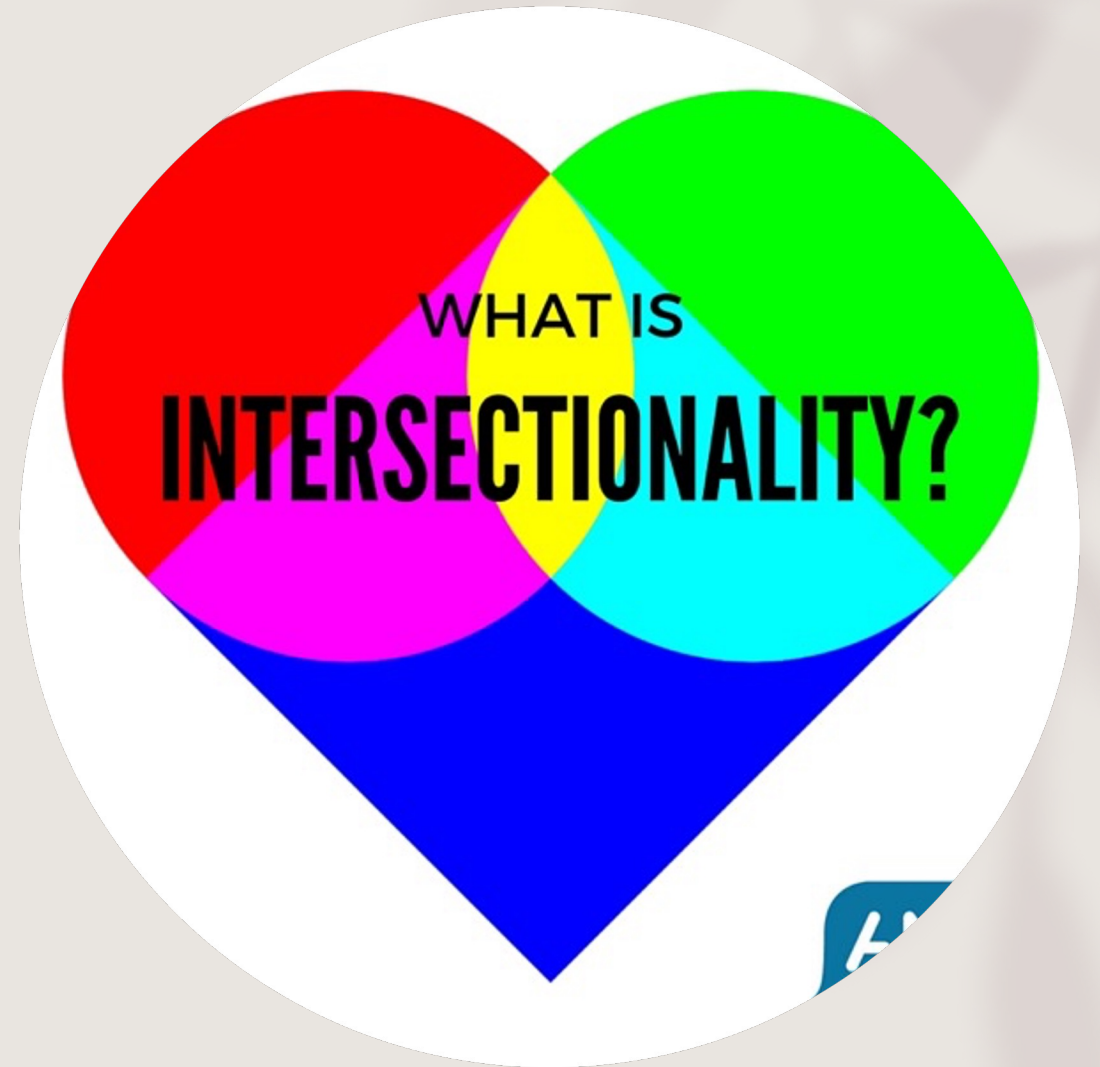
Definitional Dilemmas

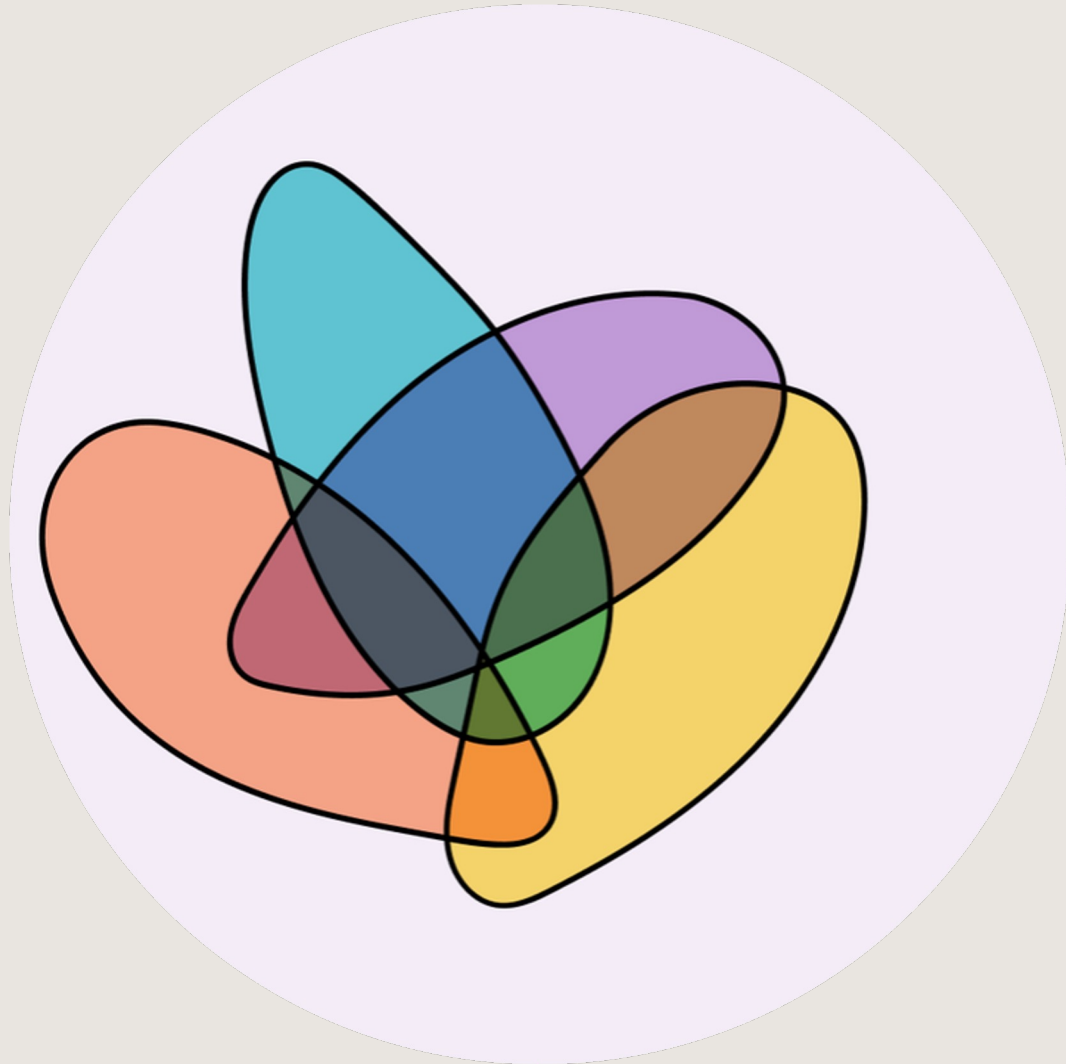
It might be challenging to represent the whole spectrum of experiences and viewpoints since social injustice is complex and intersectional.
